Welcome Janet Willey (JW): Community Speedwatch (CSW) coordinator across Essex. She reported as follows:

• The team has picked up after 18-month Covid hiatus - policy and procedure had to start from scratch.

- There are now 1300 volunteers across 100 groups. Police and highways want to onboard three new groups per month, they are assigning sites and are back to face to face training.
- Fire, highways and police meet on a monthly basis and JW updates them the group monitors changes in roads locally as well to keep CSW groups safe.
- Groups need to keep to site codes as these areas have been risk assessed to see if they are safe. The signs warn motorists about people in the road, rather than the presence of a speed trap.
- CSW is not an enforcement group and never will be, they support Safer Essex Roads Partnership which has the aim of working towards Vision Zero zero fatalities on Essex roads by 2040. Collisions make impact not just on hospitals but on mental health, salaries, jobs and children.
- This drive is worldwide to monitor and lower speed in local communities to make them safe. Lots of communities are joining if you are out for an hour, in that hour, you made a difference.
- 85% of road deaths are related to excessive speed. Drivers take notice and slow down because they are aware and will get a warning letter if they were speeding.
- Groups should submit a rota in advance which JW will send to the police, and they will send an
  enforcement officer, who has authority to pull people over, when they can, which gives groups credence.
  The Council agreed to request enforcement support, so groups please send in available dates
- JW talked of a twin towers effect. Over 3000 plus people were killed on September 11 2001, and that is less than a quarter of all the road deaths in the UK within a year. We want speeding to be seen as antisocial as drunk or drugged driving or driving without a seatbelt. It will take time. But with the help of CSW volunteers across the county, we will slow people down and make the road safer for all road users.
- Enforcement officers operate in Essex; There are 3 new ones for that role plus more assisting the Essex police, but officers may be called away on a blue light at any moment so volunteers should factor this in.
- Road traffic police unit and the Rural Crime Squad all support the groups.
- Groups must record speeds for the sheets: 36 and over in a 30 limit or 47 and over in a 40 area.
- The police can enforce but CSW do not and cannot. If the speed is excessive as logs go straight for processing and not checked by CSW groups are asked to email JW with excessive speeding. Two speeding reports may lead to a house call. When logs go to the Essex police, they have to be accurate as they may use the intelligence for other purposes.
- There is a new form, many groups were submitting the wrong side code which caused problems. People can insert site codes rather than rely on a drop down menu.
- Start and finish times go in the start is when you record the first speeder. The data is core and processed via automatic readers.
- Collection of data for CSW has a set purpose volunteers may want to collect data of all speeds but should only send the CSW the data required for the spreadsheet. The Parish Council may have a fuller dataset for our records e.g. average no of records per session is 10 but one SA group records double this in sessions.
- The question was raised about data not captured because of high speeds or motorbikes or unreadable number plates. JW agreed to investigate with PC Cook.
- There are three speed limits in one mile within this parish. JJ to raise issue of speed with the MP on 8/9/2 and point out the new buildings coming up and request reassessment for speed limits. We are trying to get figures of how many houses you need in the village to get speed reassessed
- Safer Roads Essex came to the school to teach road safety; they are not allowed to teach it outside the school because it is so dangerous. Cllr Mc Ivor is going to take this to the Highways panel.
- Two speed breaches result in letters sent and a visit by the police. CSW cannot enforce but police can. Letters do go out, as do officers.
- Cameras would assist with speed control in the village. The PC have looked into it and have considered paying for cameras, but have been informed no more speed cameras are allowed to go in for the next six months. JW to research this and report back. Stanford Rivers had the same problem.
- If a site needs to be reassessed inform the clerk who will liaise with JW.
- There is no code outside Tysea stores but there is one further up outside Towneley Cottages which is unworkable and unsafe and we request this be reassessed. JW will advise the clerk.

**Footpaths:** Report was read: The footpaths maintenance group have been doing their best to keep nettle growth down. Thanks to those involved. CB placed an article in Link Up to encourage walkers to snip along the way and ask landowners with adjacent paths to keep overgrowth from their properties clear.

- The section of footpath 22 which remains open, (north end closed due to building work at High House farm) along with adjoining section of footpath 37 put in place due to closure, was reported to enforcement due to hazardous rubble being placed along what was previously green field pathways.
- The landowner in this same area contacted regarding crops totally blocking footpaths 20/22/23 and 37.
- The section of footpath 13 which runs across the back of Brook Farm TC from Stapleford Road is totally overgrown again with brambles and thistles. Previously managers/owners have insisted they clear this themselves. Group unsuccessfully tried to make contact so passed this to enforcement.

- Derelict bridge on footpath 20 (where it leads from Bournbridge Lane northbound) replaced. Current crops prevent access to walks over the bridge due to head height maize and no cross field walkway.
- Large trees across footpath 33 behind the Top Oak Pub to Nupers Hatch have been cleared.
- Autumn jobs for the maintenance team will include clearing dying vegetation to widen paths, replacing waymarker posts knocked down in harvesting and adding waymarker posts to help identify routes.
- The group welcomes new members contact Cllr Burnett. Work times are based around availability.

Accidents: two new ones in dossier

**Bus service:** awaiting developments at Essex Council for biweekly extension of the service to Epping and to Debden. Estimated contribution from SAPC would be just over £2k per year.

- Query: The stops proposal shows the bus will not go any further than Bournbridge Lane which potentially would exclude a large section of the village, plus the walk from Bournbridge Lane is hazardous as people need to walk in the road due to overgrowth and in winter it is slippery. Clerk to ask the Community Transport team: Bournebridge Lane is safe for passengers and the minibus to turn around, but if there is passenger interest in Tysea Hill/Oak Hill they can become individual members pending the trial run.
- Oak Hill Green: could the bus be extended here as community enrichment? JJ to suggest it to developers.

Section 106 contribution: no updates from EFDC. We cannot claim until the first course of brickwork is in so nearer the time we can put it out to the village.

Crime: 3 new incidents for August.

**Footpaths Funding:** the round-up is done, checked by Clerk and by CB, and invoice is ready to present. The Council passed this for processing.

**Oak Hill Green:** latest was activity in July people on the land. Police were called. People had approached the neighbours to say they bought the land but land registry proved otherwise as JJ discovered. Landowners have secured the site now. Please tell the Clerk if anything else occurs. Section 78 has been proposed - an injunction against persons unknown.

JLR environmental: 8 wheeler grab lorries seen in the village. JJ spoke to foreman, expressed concerns about the amount of lorries coming through the village and suggested a diversion via Goatswood Lane to the site from Navestock, and not down Tysea Hill to avoid the junction. It made the houses shake on Tysea Hill and there were some near misses. The contract is only running for a few weeks and the company are sympathetic – please let us know if there are any more problems.

Extraordinary meeting: The minute of the extraordinary meeting was read and agreed

We are objecting to this application on the following grounds:

- We would initially point out that the plans are vague and some of us have experienced difficulty in viewing them.
- We are concerned about the safety of this development as it is in a flood risk area. It needs a proper drainage assessment which we do not see on the plans.
- We are concerned about the impact of this development would have on the public right of way and require clarification that the path is private or otherwise.
- This development is currently a multi-use site: there is also no indication that this would continue, which
  there ought to be.

If this application is listed to come before Committee we will register to speak.

## EPF/1795/23 The Drive, Stapleford Road, Stapleford Abbotts, Romford, RM4 1EJ Change of use to garden land Muhammad Rahman RETURN SEPTEMBER 18 2023

Two dates were given for the response to this application and we are objecting on the following grounds:

- Flood risk the properties here are in a flood risk zone. and there is no flood risk risk assessment for these properties on this application. The neighbourhood has many flooding incidents two weeks after the Blenheim Mews application was granted, three houses in Brookside got flooded
- Greenbelt incursion The land proposed to become part of these gardens is currently green belt land so
  the PC object to the use of green belt land for residential purpose and the consequent loss of such green
  belt land
- Furthermore this would allow for subsequent applications for additional housing as infill at the rear of the development that might free up the rest of the field for development which is currently greenbelt and grazing land; it has happened in other areas
- An application made earlier to extend the gardens at Field End into the field behind, which was refused by the Secretary of State (EPF/ 1925/21) This was rejected for Greenbelt incursion and flood risk - and this appeal has set a precedent for our village, so it should not be contravened here.
- Ecological concerns there is a lot of flora and fauna in this area that would be impacted the site should have an ecological assessment done. There is not one attached to the original plan. There are badgers and muntjacs known to be in the area, and newts are local to the area so there should be a survey made before anything planning-related is set in stone.
- Development creep- the developer heading up this application has been in charge of several other
  applications in the area that have amounted to "development in stages". This negates the provision of
  social housing by making separate proposals over time.
- Stapleford Abbotts local plan development exceeded

If this application is listed to come before Committee we will register to speak.
